本条款"2000年问题"系指,因涉及2000年日期变更,或此前、期间、其后任何其他日期变 更,包括闰年的计算,直接或间接引起计算机硬件设备、程序、软件、芯片、媒介物、集 成电路及其他电子设备中的类似装置的故障,进而直接或间接引起和导致保险财产的损失 或损坏问题。保险人对由于下列原因,无论计算机设备是否属于被保险人所有,直接或间 接导致、构成或引起保险财产损失或损坏由此产生的直接损失或间接损失不负赔偿责任: 1)不能正确识别日期;

<u>2)由于不能正确识别日期,以读取、存储、保留、检索、操作、判别、处理任何数据或信息,或执行命令和指令;</u>

<u>3)在任何日期或该日期之后,由于编程输入任何计算机软件的操作命令引起的数据丢失,</u> 或不能读取、储存、保留、检索、正确处理该类数据;_

<u>4)因涉及 2000 年日期变更,或任何其他日期变更,包括闰年的计算而不能正确进行计算、</u> 比较、识别、排序和数据处理;

<u>5)因涉及 2000 年日期变更,或任何其他日期变更,包括闰年的计算,对包括计算机、硬件设备、程序、芯片、媒介物、集成电路及其他电子设备中的类似装置进行预防性的、治理性的、或其他性质的更换、改变、修改。</u>

本保单所载其他条件不变。

Year 2000 Exclusion Clause of C. I. R. C.

The Year 2000 problem as referred herein means any loss of or damage to the insured property directly or indirectly caused by or arising from the failure of any computer hardware, programme, software, microchip, media, integrated circuit or similar device in other electronic equipment, concerning the date change to the year 2000 or any other date change, including leap year calculations, whether occurring before, during or after the year 2000. The Company shall not be liable under this Policy for any damage or consequential loss of the insured property directly or indirectly caused by or consisting of or arising from the under-mentioned failures and/or manipulations of any computer system, whether the property of the Insured or not:

1) failure to identify any date as its true calendar date;

2)failure to capture, save, retain, scan, manipulate, differentiate or process any data or information or execute a command or an instruction as a result of treating any date otherwise than as its true calendar date;

3)any loss of data or inability to read, save, retain, scan or process such data correctlycaused by programming any computer software command on or after an assigned date; failure to correctly calculate, compare, differentiate, sequence or process any data concerning the date change of the year 2000, or any other date change, including leap year calculations;

4) any change, alteration or modification, whether preventative, remedial or otherwise, to

5) any computer system, hardware, programme, microchip, media, integrated circuit or similar device in other electronic equipment, involving the date change to the year 2000, or any other date change, including leap year calculations.Other terms and conditions under this Policy remain unchanged.
